- A. I/We the undersigned being the Shareholder/Director/Founder/Settlor/Donor/Beneficial Owner of the proposed AND existing Labuan Entities hereby declare that at the time before and/or after registration of the Labuan Entities, I/we shall refrain or not to indulge in any sort of activities that are illegal, Immoral or unhealthy activity which include but not limited to the following:-

LIST 1. SHARIAH NON-COMPLIANT ACTIVITIES:-

No.	Activites/Sources of income	Description
1.	Financial services based on ribā	Conventional pawn broking, loan services, investments in Shariah non-compliant portfolios and financial instruments and money Lender.
2.	Gambling or activities related to gambling	Four digits, lottery, casino, horse racing club, renovation of offices for management of gambling activities, etc.
3.	Liquor related activities	Producing, distributing, marketing, and storing of liquor
4.	Pork and pork-related activities	Any product originated, mixed, and contains pork
5.	Dog and dog related activities	Pet and companionship. Any product originated, mixed, and contains dog.
6.	Non-halal restaurant including non-halal food and beverages	Selling non- <i>halāl</i> food/ dish.
7.	Shariah non-compliant entertainment	Production, acting or broadcasting of excessive Shariah non-compliant conduct such as kissing, overly exposed clothing and bedroom scene, managing of singing or dancing performance of Shariah non-compliant song(s) and action(s) that include syirik elements such as black metal, strip dancing, night club, casino etc. Reference shall be made to Garis Panduan Penapisan Filem by the Film Censorship Board of Malaysia, Kod Etika Penyiaran by Rancangan Televisyen Malaysia (RTM) and Garis Panduan Hiburan Dalam Islam by JAKIM.
8.	Gaming/amusement based shop/event	Selling gaming or amusement slot machines. Supplying tokens, gaming/amusement slot machine.

9.	Tobacco related activities	Production of any tobacco-based products, cigar, cigarette including vape and e-cigarette.
10.	Tattooing	Tattooing services.
11.	Cosmetic plastic surgery, non-medical aesthetic service	Cosmetic plastic surgery services for beauty purposes. Chemical peel (medium depth). Botulinum toxin injection. Filler Injection – excluding silicone and fat. Superficial sclerotherapy. Laser for hair removal.
12.	Cosmetic products	Contains non-halal ingredients e.g. pig fat, placenta.
13.	Spa, Saloon, massage parlour	Services mixing between male and female customer/staff. Using non-halal/syirik products.
14.	Worshipping tools/goods for religion(s) other than Islam	Incense, joss-stick. Religious Worship Shop.
15.	Sexual related shop including pornography material	Sex toys, pornography magazines: <ul style="list-style-type: none"> • Selling adult goods (sexual instrument). • Pornography Magazine.
16.	Ritual/Khurafat Element	Yoga practices or classes, which may involve khurafat/ ritual elements.

LIST 2 . NON-HALAL PRODUCTS LIST

No.	Listed Products
1.	Animal fats and oils and their fractions, boiled, oxidized, dehydrated, sulphurized, blown, polymerized by heat in vacuum or in inert gas or otherwise chemically, modified, inedible mixtures or preparation of animal fats or oils or of fractions of different fats or oils, not elsewhere specified or included.
2.	Animal fat and oils and their fractions.
3.	Bacon.
4.	Beer made from malt.
5.	Bellies (streaky) and cuts thereof.
6.	Bones and horn- cones, unworked, defatted, simply prepared (but not cut to shape), treated with acid or degelatinized, powder and waste of these products.
7.	Bovine semen.

8.	Collections and collectors' pieces of zoological, botanical, historical, mineralogical, anatomical, archaeological, etc.
9.	Decoration items with non-Islamic religious motives.
10.	Edible offal of swine, fresh, chilled and frozen.
11.	Fats of bovine animals, sheep and goats.
12.	Frogs' legs and any part thereof.
13.	Guts, bladders and stomach of animals (other than fish), whole and pieces thereof, fresh, chilled, frozen, salted, in brine, dried and smoked.
14.	Hams, shoulders and cuts thereof, with bone in.
15.	Homogenized preparations
16.	Human hair, unworked, whether or not washed and scoured, waste of human hair
17.	Imitation lard
18.	Lard stearin, lard oil, not emulsified or mixed or otherwise prepared.
19.	Live swine.
20.	Liver of any non-halal animals.
21.	Meat of swine, fresh, chilled or frozen.
22.	Mixtures or preparations of animal fats or oils or of their fractions.
23.	Original sculptures and statuary, in any material.
24.	Other animal fats and oils and their fractions, whether or not refined, but not chemically modified.
25.	Other fermented beverages i.e. cider, perry or mead.
26.	Pig fat (including lard).
27.	Pig fat free of lean meat, fresh, chilled, frozen, salted, in brine, dried or smoke.
28.	Pigs', hogs' or boars' bristles and hair and waste thereof.
29.	Pork.
30.	Pork- salted.
31.	Preparation of blood on any animals.
32.	Swine- hams and cuts thereof.
33.	Swine- raw hides and skins.
34.	Swine- tanned or crust hides and skins (in dry state- crust).
35.	Swine- tanned or crust hides and skins (in wet state including wet blue).
36.	Undenatured ethyl, alcohol of an alcoholic strength by volume of 80% volume or higher, ethyl alcohol and other spirits, denatured, of any strength.
37.	Undenatured ethyl, alcohol of an alcoholic strength by volume of less than 80% volume, spirit, liquors and other spiritous beverages.
38.	Vermouth of other wines of fresh grapes flavoured with plants or aromatic substances.
